



The following Affidavit is submitted to the Court to document the probable cause in support of a request for the issuance of an Arrest Warrant for Brent Jeremie Stein, DOB: 01/22/1974, SSN: [REDACTED]

This offense is fully documented in Offense Report 20-01074 detailing the offense(s) of: **18-3-402 (1) (h) SEXUAL ASSAULT, a CLASS 3 FELONY.**

With the victim(s) identified as:

On Thursday, June 18, 2020, at approximately 2230 hours, your Affiant, herein referred to as I, was informed of a possible sexual assault occurring in Florissant Colorado, reported to the Teller County Sheriff's Office by Sexual Assault Nurse Examiner Constance Whitrock of the Memorial Central Hospital, located at 1400 E. Boulder St. in Colorado Springs Colorado. I was informed the victim was currently having a sexual assault nurse's exam conducted at this hospital and due to [REDACTED] fear of reprisal from the suspect, [REDACTED] did not initially report to law enforcement.

On Friday, June 19, 2020 at approximately 0004 hours, I arrived at Memorial Central Hospital where I met with Nurse Whitrock. Nurse Whitrock explained she had just completed the SANE on [REDACTED] date of birth [REDACTED] herein referred to as the victim. Nurse Whitrock expressed her concern regarding the details disclosed to her by the victim (who suffers from [REDACTED]). The victim met Pharmacist Brent Stein, date of birth 01/22/1974, herein referred to as the suspect, via the internet recently and was lured by him from [REDACTED] home in Indiana after he explained his late wife died of similar issues and he had the ability to "cure" [REDACTED]. The victim previously gave Nurse Whitrock the suspect's business card from "Mountain Key Pharmacy" located at 18172 CR 1 in Florissant, Colorado, which I took into my possession. Nurse Whitrock stated the victim disclosed to her the suspect gave the victim multiple medications which [REDACTED] trusted were for [REDACTED] medical issues. Many of

these medications caused [REDACTED] to become incapacitated and [REDACTED] was subjected to unwanted [REDACTED] and anal intercourse multiple times. The last sexual assault was said to have occurred on Tuesday, June 16, 2020. Nurse Whitrock stated there were signs of trauma in the "5 o'clock location" near the victim's anus.

I spoke with the victim who was visibly shaken, in a private waiting room. The victim explained [REDACTED] was born with [REDACTED] which caused [REDACTED] to be severely [REDACTED] and reliant on [REDACTED] which I observed. Due to the [REDACTED] such as [REDACTED] as well as two other strains of bacteria have [REDACTED] leading to an elevated risk of a life threatening [REDACTED]. The victim was set to [REDACTED]. The victim recently met the suspect on an E-Harmony dating site on Monday, June 08, 2020. The suspect, once informed of the victim's [REDACTED] problems, touted he had personal experience with [REDACTED] exact medical condition, and he had the ability to "cure" [REDACTED]. Fearful of the upcoming [REDACTED] which [REDACTED] believed could potentially leave [REDACTED] six-year-old son without a [REDACTED], the victim booked a flight to Colorado Springs to spend six days with the suspect for his medical care, and arrived two days later, on June 10, 2020.

The suspect explained he wanted to "court [REDACTED]" and [REDACTED] told him [REDACTED] was not interested in a sexual relationship at the time. The suspect originally told the victim [REDACTED] could stay in [REDACTED] own bedroom while at his home although he pushed for [REDACTED] to stay in his bedroom upon [REDACTED] arrival and [REDACTED] complied. During the first night of the victim's stay, the victim engaged in consensual kissing with the suspect and cuddled with him while in his bed. The victim told the suspect [REDACTED] did not want to have sex with him multiple times although he engaged in "putting his dick" in [REDACTED], ejaculating on [REDACTED] stomach against [REDACTED] will. Following this, the suspect apologized and told [REDACTED] he would "take it slow" and [REDACTED] forgave him justifying the "forced sex" to be due to the suspect being "lonely and horny." The victim expressed [REDACTED] embarrassment for putting [REDACTED] in this situation and explained the suspect was highly manipulative throughout the experience.

The victim told me the suspect gave [REDACTED] large syringes filled with an unknown liquid to inject into [REDACTED] nose which were explained to have healing qualities. The victim later supplied me with two of these 60 ml syringes filled to capacity with an unknown clear liquid. During [REDACTED] stay, the suspect also repeatedly put tablets and circular white pills manually into [REDACTED] mouth, whose side effects left [REDACTED] feeling extremely lethargic, unable to move [REDACTED] arms and legs and trouble moving/feeling [REDACTED] tongue. The victim had difficulty recalling the amount of times [REDACTED] was sexually assaulted both [REDACTED] and one time in the anus by the suspect while in the incapacitated state but [REDACTED] estimates it to be at least seven times between 06/10/2020-06/16/2020. The victim explained [REDACTED] told the suspect "No!" and "Don't put your dick in me!" which the suspect disregarded. The victim recalls all incidents to have occurred on the suspect's bed. The suspect began to tell the victim things like "He was ordained by God to put his baby in [REDACTED]" and "It was [REDACTED] destiny to carry his son." The suspect was supposed to drive victim back to the airport on 06/16/2020 for [REDACTED] return flight and he failed to do so. The victim provided me with [REDACTED] incoming and outgoing flight information which were for the explained dates.

The victim described the suspect's home to me in great detail stating it was located at [REDACTED] in Florissant, Colorado. I pulled up a photo of the home located at the address from the internet and

observed it to be of the same description and the victim confirmed this to be the suspect's residence. The victim also described the inside of the suspect's home to include the suspect's bed which [REDACTED] remembered being a queen size and having a wooden bedframe with drawers, no box spring, a "wooden slay back" adorned with a grey fitted sheet, a grey regular sheet, a "fuzzy" navy blue blanket, a white down comforter, and several firm pillows. The victim stated [REDACTED] saw [REDACTED] blood and the suspect's ejaculate on the sheets and the comforter. The suspect also "wiped his cum" on a pink polo shirt during one occasion. The victim provided me with a picture of [REDACTED] and the suspect who was wearing the aforementioned pink shirt.

On the afternoon of 06/17/2020, the victim reached out via phone call to an acquaintance of the suspect [REDACTED] met earlier in the week, John Eshlemen who picked [REDACTED] up from the suspect's home while the suspect was working at his pharmacy. Mr. Eshlemen drove the victim to a family members home located at [REDACTED] in Florissant, Colorado where [REDACTED] has been seeking refuge from the suspect who has been blocked from contacting [REDACTED] on [REDACTED] phone. While driving the victim, Mr. Eshlemen explained to [REDACTED] he has helped two other women associated with the suspect although the details of these encounters were not discussed.

The suspect when asked by the victim, would not tell [REDACTED] what medications he was giving [REDACTED]. I observed the victim's text conversations between [REDACTED] and the suspect who denies giving [REDACTED] medication and states "Wish you were okay, so sad. I'm sorry I didn't know. Wish you can forgive. Then you will heal. Sorry." The victim showed me photographs [REDACTED] took before leaving the suspect's home of medications [REDACTED] found in a red basket on top of his refrigerator. The medications are prescribed to the suspect from his pharmacy whose shape, size, and color were the likeness of what [REDACTED] remembers the suspect giving [REDACTED]. The pictured prescriptions were Metoprolol, used for hypertension, Carvedilol, a beta blocker, and Montelukast, a Leukotriene inhibitor. The victim elaborated to me about the likeness of the Metoprolol tablets to what the suspect had given [REDACTED] recalling their same shape, size, color, and the indented line across the tablets which [REDACTED] remembered feeling against [REDACTED] tongue. Upon researching the known side effects of Metoprolol I found some to include blurred vision, dizziness, unusual tiredness or weakness, difficulty moving, and the inability to move the arms, legs, or facial muscles.


The victim explained [REDACTED] was fearful of what medications the suspect had given [REDACTED] due to the severe side effects [REDACTED] endured and [REDACTED] went to the UC Health emergency room at the Pikes Peak Regional hospital located in Woodland Park Colorado on 06/17/2020. The victim showed me the correlating medical paperwork which [REDACTED] had on hand. The victim was [REDACTED] due to the suspect "bragging" he had impregnated [REDACTED].

When I spoke with the victim later in the day, [REDACTED] showed me more text conversations between [REDACTED] and the suspect. The victim explained before leaving the suspect's home, the suspect took possession of [REDACTED] cellular phone without [REDACTED] knowing and looked through [REDACTED] stored photographs, where he found photographs of the victim wearing underwear and forwarded them to his cellular phone without [REDACTED] permission. When confronted, the suspect told the victim he wanted photographs of [REDACTED] he could pleasure himself to. I observed these photographs in the text correspondence between the suspect and

victim. The victim explained [redacted] was fearful the suspect may have taken inappropriate footage of [redacted] while [redacted] was incapacitated.

The victim also informed me [redacted] and the suspect's sister [redacted] date of birth [redacted] who lives in California, have been in touch via phone since [redacted] arrived in Colorado. When alerted about the sexual assaults by the victim via phone call, Mrs. [redacted] confronted the suspect. The victim showed me a screen shot Mrs. [redacted] took of a text correspondence between herself and the suspect which she sent to the victim. The conversation shows Mrs. [redacted] writing, "WRONG! What did you do wrong? Nothing?" The suspect replies "But I have repented and God has forgiven me now I must change my behavior. I'm fully responsible no sex before marriage." Mrs. [redacted] replies, "How about no forced sex? EVER!" The suspect replies "I f\*\*\*\*\* up." The suspect is currently a probation client and is the restrained party from a [redacted] victim in a mandatory protection order concerning his 01/04/2019 conviction of Harassment and Domestic violence, (reference Douglas County District Court case # 2018CR556).

I would respectfully request that probable cause be found that Brent Jeremie Stein, DOB: 01/22/1974, did within the County of Teller and State of Colorado, commit in violation of the Colorado Revised Statutes 1973 as amended, the offense(s) of **18-3-402 (1) (h) SEXUAL ASSAULT, a CLASS 3 FELONY.**
